

ARTICULATION AGREEMENT

between STATE UNIVERSITY OF NEW YORK COLLEGE OF AGRICULTURE AND TECHNOLOGY AT COBLESKILL

and

EASTERN SUFFOLK BOCES

AUGUST 2022 – AUGUST 2027

The State University of New York College of Agriculture and Technology at Cobleskill and Eastern Suffolk BOCES jointly endorse this articulation agreement impacting graduates successfully completing the Early Childhood Education program. It is the intent of this agreement to recognize the breadth and depth of this program as a foundation for students who matriculate at SUNY Cobleskill. A candidate from Eastern Suffolk BOCES who:

- 1. Receives a New York State high school diploma
 - Follows the Eastern Suffolk BOCES Early Childhood Education curriculum, achieving an 85
 average or higher in each course included in the above curriculum and meets all other SUNY
 Cobleskill admission requirements for their major
 - 3. Receives a written recommendation from the Eastern Suffolk BOCES Early Childhood Education instructor

will be offered by SUNY College of Agriculture and Technology at Cobleskill, Department of Early Childhood:

- Guaranteed admission into the Early Childhood AAS, AS or BS degree program provided that the student meets admission requirements for the program and that there is availability within the program
- 2. Will receive advanced standing credit for SUNY Cobleskill's course ECHD 101 Basics of Early Childhood (3 credits), pending review of student's portfolio

The student must complete and file a SUNY Cobleskill Admissions Application according to instructions. The letter of recommendation from the Early Childhood Education instructor must accompany the application stating the student attends this institution, which has an articulation agreement with SUNY Cobleskill.

The effective date of this agreement is August 1, 2022, and will be reviewed for renewal, five years after signing, by the participating parties.

1 Persons not meeting these criteria have the option of applying to SUNY Cobleskill under regular admission procedure.
