

ARTICULATION AGREEMENT

between

STATE UNIVERSITY OF NEW YORK
COLLEGE OF AGRICULTURE AND TECHNOLOGY AT COBLESKILL

and

CAYUGA-ONONDAGA BOCES

MARCH 2023 – MARCH 2028

The State University of New York College of Agriculture and Technology at Cobleskill and Cayuga-Onondaga BOCES jointly endorse this articulation agreement impacting the graduates successfully completing the Plant, Animal, and Life Sciences program. It is the intent of this agreement to recognize the breadth and depth of this program as a foundation for students who matriculate at SUNY Cobleskill as a major within the Animal Science Department. A candidate¹ from Cayuga-Onondaga BOCES:

1. Receives a New York State high school diploma
2. Follows the Cayuga-Onondaga BOCES Plant, Animal, and Life Sciences curriculum and achieves an 85 average or higher in each course included in the above curriculum and meets all other SUNY Cobleskill admission requirements for their major
3. Has a written recommendation from Cayuga-Onondaga Plant, Animal, and Life Sciences program instructor

will be offered by SUNY College of Agriculture and Technology at Cobleskill:

1. Guaranteed admission into an Animal Science Department degree program, provided that the student meets admission requirements for the program and that there is availability within the program.
2. Will receive advanced standing credits for SUNY Cobleskill's course ANSC 101 Foundations in Animal Science (3 credits)

The student must complete and file a SUNY Cobleskill Admissions Application according to instructions. The letter of recommendation from the Plant, Animal, and Life Sciences program instructor must accompany the application stating the student attends this institution, which has an articulation agreement with SUNY Cobleskill.

The effective date of this agreement March 1, 2023, and will be reviewed for renewal, five years after signing, by the participating parties.

¹ Persons not meeting these criteria have the option of applying to SUNY Cobleskill under regular admission procedure.


