

"1+1" Transfer Agreement
between
STATE UNIVERSITY OF NEW YORK
COLLEGE OF AGRICULTURE AND TECHNOLOGY AT COBLESKILL
and
FULTON-MONTGOMERY COMMUNITY COLLEGE

This agreement establishes procedures to promote the easy transition of students from Fulton-Montgomery Community College (FMCC) to the Paramedic Associate in Applied Science degree program at the State University of New York College of Agriculture and Technology at Cobleskill (SUNY Cobleskill).

Terms of the Agreement

Students from Fulton-Montgomery Community College who complete the pre-requisites as specified below, with a minimum overall grade point average of 2.25 for the first year of study, will be guaranteed acceptance to SUNY Cobleskill as a second year student. If the class is full, the student will be given the highest priority for the next year.

This guarantee provides the opportunity to complete the SUNY Cobleskill Paramedic Associate in Applied Science degree through the Paramedic Program, normally requiring no more than one year of academic work at Cobleskill, including a summer Field Clinical rotation at one of our affiliate EMS agency sites.

Major field coursework (BIO 181 & 182 and ENG 103) require grades of C or higher to be accepted for transfer credit.

*Cobleskill EMSC 112 Emergency Medical Technician is challengeable via a grade of 85% or higher on the New York State (NYS) DOH Bureau of EMS (BEMS) EMT written certification exam and the successful completion of a NYS DOH BEMS or NREMT Practical Skills Examination within three years of the first day of Paramedic classes. Every student must maintain NYS EMT certification throughout the duration of paramedic coursework.


Termination



Effective Date and Signatures


This agreement will become effective October 2012, upon acceptance of Agreement with appropriate signatures.
