Resources and Policies for Faculty, Staff and Students

#### Title IX

No person in the United States shall, on the basis of sex be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance

The College has a duty to promptly respond to complaints of sexual harassment and sexual violence in a way that limits its effects and prevents its reoccurrence.

The Title IX Coordinator's responsibilities include overseeing all complaints of sex discrimination and identifying and addressing any patterns.

#### **Sexual Violence**

- Sexual Harassment
- Sexual Assault/ Forcible Touching
- Domestic/ Dating Violence
- Stalking

#### What to do

If someone tells you they have experienced sexual violence:

- Offer support, listen and encourage them to seek help and counseling as soon as possible
- If immediate safety is a concern, call 911
- Report the incident to the Title IX Coordinator

#### What to do

If you have experienced sexual violence:

- Get safe
- Get medical help
- Get emotional help and support

#### What to know

- It was not your fault
- You are in control
- Many resources are available to you on campus and in the community
- You have the right to choose whom and what to tell, and when
- If you report, you'll be taken seriously and treated with dignity and respect

#### SUNY Cobleskill

- Does not tolerate sexual harassment, sexual assault, relationship violence or stalking
- Does not tolerate retaliation against anyone reporting sexual violence or participating in an investigation or conduct process
- Has amnesty policy for alcohol/drug us in sexual violence cases.

#### Choose the options best for you

- Speak confidentially to a professional counselor
- Submit an anonymous report
- Report to law enforcement
- Report to Title IX

#### Who needs to report to Title IX?

Students, faculty and staff. If a student reports an incident to a faculty or staff member they believe has the authority or duty to address it, they are considered by the Office for Civil Rights to be a "responsible employee." They must promptly – within 24 hours – report the incident to the Title IX Coordinator on campus.

When in doubt on whether or not to report, contact the Title IX Coordinator 518-255-5229

#### Why you need to report

- To ensure the individual has access to all available resources and options
- For campus and community safety
- To comply with Title IX and other federal regulations

#### What to tell the individual

Their disclosures will be taken seriously, and they'll be treated with dignity and respect. Victim/ survivor privacy is carefully maintained, and they have the right to receive assistance from the College a well as the right to make a report to law enforcement.

#### Prohibition on retaliation

SUNY Cobleskill will not tolerate retaliation against anyone for filing a complaint or participating in an investigation.
